

**PRIVACY POLICY**  
**LAST REVISED ON: MAY, 2017**

Personal information about the users to the application entitled **AIM Real Focus** and available for download at the App Store and the Google Play Store (the “**App**”) is collected, used and disclosed in accordance with the British Columbia *Personal Information Protection Act* (“**PIPA**”) and, to the extent applicable, the Canada *Personal Information Protection and Electronic Documents Act* (“**PIPEDA**”). Aimcor Investments Ltd. (the “**Company**”) takes your privacy and the collection, storage and maintenance of your personal information seriously.

**Personal Information**

Personal information is information about an identifiable individual, such as an individual's name, address, birth date, e-mail address and phone number.

**Collection and use of personal information**

When you access and use the App, information may be automatically collected about your access and use of the App using temporary cookies, in an effort to provide you with an optimal user experience and to improve the App. By continuing to use the App, you agree to the use of cookies. If you do not agree to the use of cookies by the App, you should not access, use, or continue to use the App, delete any cookies after having accessed the App, or use any anonymous usage settings available to you.

If you send us e-mail, we may collect your email address, your internet IP address and your message so that we may reply to you. We may also collect any other personal information you choose to provide to us, such as your name or telephone number. Sensitive personal information should not be sent to us unencrypted over the Internet or by e-mail.

Except as expressly set forth in the Terms of Use for the App (found on and through the App), the personal information we collect is only used for the original purposes it was collected or in a manner consistent with those purposes. We may disclose your personal information, to the extent necessary, in the following circumstances:

- a) to third-party contractors or service providers that assist in the improvement and maintenance of the App;
- b) to our affiliates, successors and assigns;
- c) in connection with a corporate transaction such as a merger, consolidation, share sale or asset sale;
- d) in connection with the bankruptcy or insolvency of the Company or our affiliates, successors and assigns;
- e) to protect the safety of any person or to address fraud, security or technical issues; and
- f) as otherwise directed by you.

**Aggregate or de-identified data**

We may also disclose information that has been aggregated or that otherwise does not personally identify you to third parties and affiliates who may use it for analytics, trends and analysis to improve and provide our products and services, including the App.

**Legal requests**

If we receive a subpoena, warrant, discovery order or other request or order from a law enforcement agency, court, other governmental entity, or litigant that seeks data relating to the App (collectively a

“Legal Request”), we will make reasonable attempts to direct the requesting party to seek the data directly from you. If we ask the requesting party to direct the request to you, we will provide your contact information to the requesting party. If legally compelled to produce information and unless legally prohibited, we will use reasonable efforts to notify you so they can notify you as permitted by law. We will direct any requests for information under data protection laws to you, unless prohibited by law.

### **Protection of personal information**

We protect your personal information by using industry standard security arrangements against unauthorized access or disclosure. Access to systems, applications and data is restricted to authorized individuals of the Company only unless otherwise provided herein.

### **Links to other sites**
